RESULTS AND DISCUSSION:

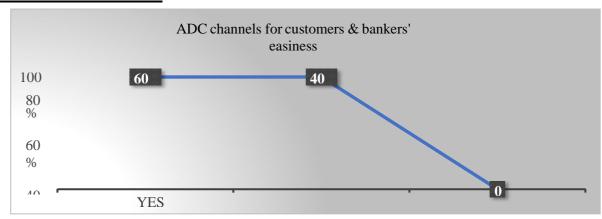


Figure 1: ADC channels for customers & bankers' easiness

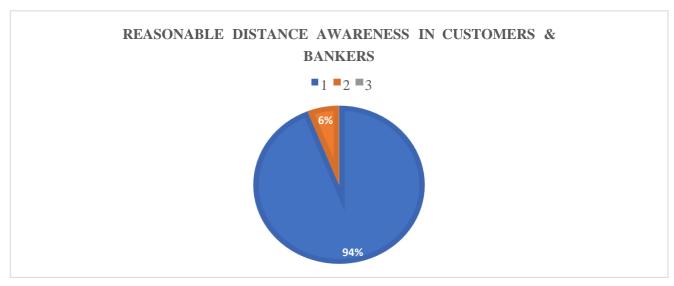
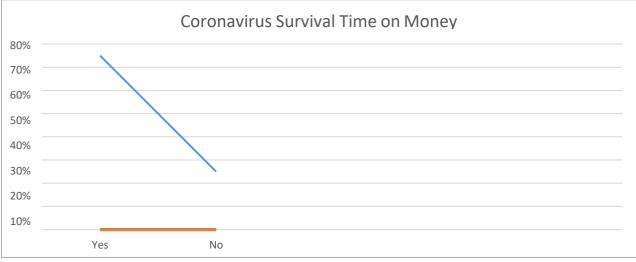


Figure 2: Reasonable distance awareness in customers & bankers

This graph shows that mostly bankers have awareness that for how much time corona virus can survive on surface of money. The ratio is about 75% of total sample for this question.

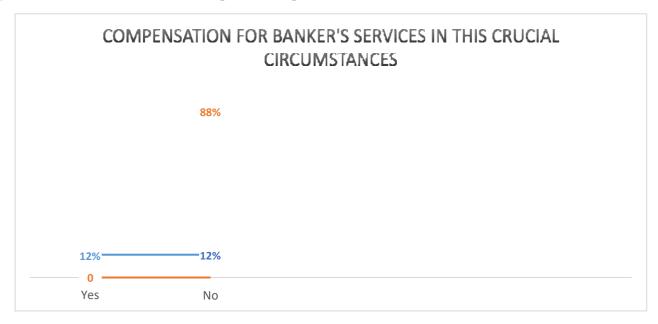


Figure 4: Compensation for banker's services in this crucial circumstance
